

CALIFORNIA PIZZA KITCHEN—SHARE THE MOMents 2018
OFFICIAL RULES

- * **No Purchase or payment is necessary to enter or win.**
 - * **Entrants must comply with all applicable laws and these Official Rules.**
 - * **All submissions must be respectful and consistent with CPK’s family-friendly brand and reputation.**
1. **NO PURCHASE OR PAYMENT NECESSARY.** A purchase or payment will not increase your chances of winning.
 2. **PROMOTION PERIOD AND SPONSOR.** The SHARE THE MOMents 2018 SWEEPSTAKES (“Sweepstakes”) runs from April 24, 2018, at 12:01 a.m. (PDT) to May 28, 2018, at 11:59 p.m. (“Promotion Period”), and is sponsored by California Pizza Kitchen, Inc. (“Sponsor”).
 3. **ELIGIBILITY.** The Sweepstakes is open to legal residents of the 50 United States, and the District of Columbia, **except Rhode Island.** VOID WHERE PROHIBITED. Participants (hereafter “Participants”) must be at least 18 years of age at the time of the Sweepstakes. Valid proof of age will be required to collect any prize. Employees of Sponsor and Sponsor’s franchisees, parents, affiliates, distributors, retailers, advertising agencies, promotion agencies, and judging agencies (and the immediate families and household members of each of the foregoing) are not eligible to win.

Individuals entering the sweepstakes (“Entrants”) are not required to register, pay any entrance fees or make any expenditure in order to participate in the Sweepstakes or win a prize. Sponsor will contact the “winner” through the applicable social media channel comment thread asking the winner to direct message Sponsor to claim the prize. Each winner will be notified by message (via their specific method of

entry) within three days of selection and will be required to respond by within 48 hours of notification or the prize will be forfeited and an alternate winner selected.
